## **CITIZEN TIME**

Mohamed Youssef signed up to speak regarding hot water issues he is experiencing as a resident of Herndon Harbor House. He explained that despite the building having a centralized hot water system that service all 30 units, hot and cold water gets mixed unexpectedly and involuntarily. Mr. Youssef stated this has been an issue for over two years. Building management is aware of the issue but has been unable to resolve it. Mr. Youssef requested that the Board investigate this matter on behalf of the Herndon Harbor House residents.

#### **RESOLUTION NUMBER 37-23**

Award of Federal HOME Investment Partnerships Program (HOME) Funding to a Fairfax County Nonprofit Affordable Housing Organization

BE IT RESOLVED that the Fairfax County Redevelopment and Housing Authority (FCRHA) authorizes the Chairman, Vice Chair, or any Assistant Secretary of the FCRHA to negotiate, execute and deliver contracts, loans and any other necessary or appropriate documents or agreements, in accordance with the applicable federal regulations for the use of HOME Investment Partnerships Program Fund, with the following nonprofit organization, as more fully described in the Item presented to the FCRHA at its December 14, 2023, meeting:

> (1) \$342,482 to Good Shepherd Housing and Family Services, Inc. to purchase one 3- or 4-bedroom townhouse in the Hagel Circle neighborhood. Good Shepherd will provide residents with rental housing and services to support their progress toward self-sufficiency. The unit will serve one family of 5 to 8 individuals, that has a household income of up to 60% of AMI and is at a high risk of homelessness or has experienced homelessness.

Vice Chair Lardner moved to adopt Resolution Number 37-23, which Commissioner Zurawski seconded. The motion passed unanimously.

#### **RESOLUTION NUMBER 38-23**

Authorization to Amend Certain Loan Terms for Coralain Gardens Apartments, 7435 Arlington Boulevard, Falls Church, VA 22042 (Mason District)

**WHEREAS**, the Fairfax County Redevelopment and Housing Authority (FCRHA) has authorized Enterprise Community Development (the Purchaser) to assume the existing loan balance on Coralain Gardens Apartments (the Property) to assist in financing the purchase of the Property and to extend the affordability of the apartments;

**WHEREAS,** the Purchaser has proposed changes to certain loan terms to assist in their purchase of the Property; and

**WHEREAS**, the FCRHA agrees to assist the Purchaser to acquire the Coralain Gardens Apartments by authorizing the proposed changes to the loan terms.

**NOW, THEREFORE, BE IT RESOLVED** that the FCRHA hereby authorizes the amendment of certain loan terms, as more fully described in the Action Item presented to the FCRHA on December 14, 2023 (Action Item), and:

**BE IT FURTHER RESOLVED** that the FCRHA authorizes Thomas E. Fleetwood, Assistant Secretary, or any Assistant Secretary to negotiate all loan terms on behalf of the FCRHA and authorizes its Chairman, Vice Chairman or any Assistant Secretary to execute all documents, agreements, and instruments necessary or appropriate in connection with the assumption of the Loans for the acquisition of the Property, consistent with the Action Item and previous FCRHA authorizations.

Commissioner Alexander moved to adopt Resolution Number 38-23, which Commissioner Kennedy seconded. The motion passed unanimously.
